
Scope Markets 2021 Deposit Bonus Promotion Terms and Conditions

The Chinese translation to the present Terms and Conditions is provided for convenience only. In case of contradiction, the English version shall prevail.

1. Introduction

活动简介

- a. Scope Markets is a trading name of Scope Markets Ltd a Company incorporated in Belize with registration number 145,138, having its registered address at 5 Cork street, Belize City, Belize (hereinafter referred to as ‘Scope Markets’ or ‘the Company’). The Company is regulated by the International Financial Services Commission of Belize (IFSC) under license numbers 000274/221 and 000274/222.

- b. This Bonus (hereinafter referred to as “Bonus” or “Offer” or “Promotion”) is available to clients of Scope Markets who meet the Eligibility Criteria and perform Eligible Deposits as described herein.
赠金转现推广活动（“赠金”或“优惠”或“活动”）适用于任何满足活动参与资格的 Scope Markets 斯科普客户。
- c. The Client acknowledges that he/she has read and agreed to be bound by these Terms and Conditions as well as to the Company Trading Terms and Conditions.
客户确认他/她已阅读并同意接受这些条款和条件以及 Scope Markets 斯科普的交易条款和条件的约束。
- d. The Deposit Bonus Promotion includes the “Welcome Credit Bonus” available only to New Clients and the “Deposit Credit Bonus” available to New and Existing Clients. Furthermore, this Promotion is consisted of two parts: the receipt of the ‘Credit Bonus’ and/or the Welcome Credit Bonus if applicable, and the conversion into “Trade Cash Bonus” under the terms provided hereunder.
赠金转现推广活动包含了对新客户提供的“迎新赠金”，以及对新客户和现有客户提供的“入金赠金”。本次活动由“达成相应条件后获得赠金”和“在遵守本合同规定的条款下将赠金转换为现金”两个部分组成。

2. Promotion Period

活动时间

- a. The Period to become Eligible and apply for the **Deposit Bonus** Promotion is **from 17:00 EDT # on June 30, 2021 to 16:59 EDT# on July 30, 2021.**
EDT (US Eastern Standard Time) is GMT -5, BJT (Beijing Time) is GMT +8 赠金转现推广活动时间：美国东部夏令时# 2021 年 6 月 30 日 17:00 -- 美国东部夏令时# 2021 年 7 月 30 日 16:59。

- b. The deadline to complete the required volume in order to be eligible to convert the Welcome and/or Deposit Credit Bonus into Trade Cash Bonus is **6 months (180 days) from the time the Eligible Deposit was performed for the first time.**
客户需于首笔合格入金后的 6 个月 (180 天) 内完成指定交易量方有资格获取交易赠金。
- c. If the volume requirement hasn't been met in the client's account within 6 months (180 days) after the Eligible Deposit was performed for the first time, in order for the Trade Cash Bonus to be awarded, then the account will be automatically disqualified from the promotion and any amount of credit bonus will be removed.
客户如在首笔合格入金后的 6 个月 (180 天) 内未能完成指定交易量要求，其账户将自动取消活动资格，所有赠金将被撤销。

3. Conditions of Eligibility

参与资格与条件

- a. An individual who can agree to binding contracts under the laws applicable in their country of residence may participate in the **Deposit Bonus Promotion.** Without limiting the foregoing, participation in the **Deposit Bonus Promotion** is not allowed for persons under the age of 18 or otherwise under legal age in their country of residence ("minors"). **If you are a minor, you cannot not participate in the Deposit Bonus Promotion.**
根据客户居住地适用的法律，能够同意签订具有约束力的合同的个人可以参加赠金转现推广活动。在不限制上述规定的情况下，未满 18 周岁或未满法定年龄的人士（“未成年人”）不允许参加赠金转现推广活动。如果您是未成年人，您不能参加本次活动。
- b. The "Deposit Credit Bonus" and the "Trade Cash Bonus" are available to clients who have a live trading account with the Company and have submitted valid KYC documentation as per the Company's requirements as those are amended from time to time at the sole discretion of the Company (hereinafter 'Clients').

所有在 Scope Markets 斯科普拥有真实交易账户并已根据相应要求提交有效 KYC 文件且通过审核的客户，均有资格申请本次活动。

- c. The Welcome Credit Bonus Offer is available only to new clients who have not funded their account yet and performed their first deposit into a Standard or Pro account during the Promotion Period. They must have submitted valid KYC documentation as per the Company's requirements as those are amended from time to time at the sole discretion of the Company (hereinafter 'New Clients').

- d. Platinum accounts, IB commission and trading accounts, Institutional accounts and same-name accounts are not eligible to participate in the Deposit Bonus Promotion.

- e. Employees (including relatives, partners and spouse), partners or introducers of Scope Markets, or anyone associated with the company are not permitted to participate in this **Deposit Bonus Promotion**.

Scope Markets 斯科普员工 (包括其亲属, 伴侣和配偶)、合作伙伴或介绍人, 或任何与 Scope Markets 斯科普有关联的人员都不允许参加本次赠金转现推广活动。

- f. Participation of 'Intermediaries/Related Parties' in the **Deposit Bonus Promotion** is prohibited. If the registration and/or trading date of a participant in the **Deposit Bonus Promotion** corresponds with the registration and/or trading information, including but not limited to IP address, trading from the same device of another participant in the **Deposit Bonus Promotion**, Scope Markets reserves the right to regard this matching as a reason for immediate disqualification. For the purposes hereof, the term 'Intermediaries/Party(ies)', when used in these Terms and Conditions, unless the context otherwise requires, shall mean to include any person or entity bearing a relationship with any participant in the **Deposit Bonus Promotion**, including without limitation:

- 1) Family member, such as brothers, sisters, spouses, ancestors, lineal descendants, and collateral descendants.

- 2) Person or entity, whom any participant in the **Deposit Bonus Promotion**, directly or indirectly through one or more intermediaries, controls, or whom directly or indirectly through one or more intermediaries, is controlled by or is under common control with any participant in the **Deposit Bonus Promotion**, for purposes of this definition, the term 'control' (including with correlative meaning, the terms 'controlled by' and 'under common control with'), as used with respect to any participant in the **Deposit Bonus Promotion**, shall mean the possession, directly or indirectly through one or more intermediaries, of the power to direct or cause the direction of management policies of such person or entity, whether through ownership of voting securities or otherwise.

任何参加赠金转现推广活动的个人或实体,直接或间接操纵一个或多个中介机构,或直接或间接被一个或多个中介机构操纵或者和此活动的参加者共同操纵。为了明确这个定义,术语“操纵”(包括与之相关意义,“被操纵”和“共同操纵下”),在这里意味着,直接或间接实际掌管一个或多个中介机构并能做决策某些个人或实体,可能利用投票证券的所有权或其他方式进行套利。

- 3) Similarly, persons associated in any manner whatsoever with Scope Markets and/or with the specific websites and/or social network sites on which Scope Markets may be running from time-to-time certain specific bonus/promotions, contest and/or surveys, in the context of which access to the **Deposit Bonus Promotion** is offered, are not allowed to participate in the offer.

- g. This Offer cannot be combined with any other Bonus/Promotions Scope Markets may offer. Should a Client's trading account already have an existing Bonus, they will not be able to opt-in to this promotion or by accepting these Terms and Conditions; the Client also accepts that the previous Bonus will be removed prior to the new Offer being applied.

- h. In order to be eligible to receive the Welcome Credit Bonus, New Clients must perform their first deposit of a minimum total amount of 100 USD within one natural day as defined hereunder (hereinafter 'First Eligible Deposit').

- i. In order to be eligible to receive the Deposit Credit Bonus, Clients must perform a deposit of a minimum amount of 500 USD during the Promotion Period (hereinafter 'Eligible Deposit').

为顺利获得入金赠金，客户须完成单笔最低 500 美元的入金要求。

- j. A natural day definition: from 17:00 EDT on the previous day to 16:59 EDT (daylight saving time), for example, the natural day on July 13, 2021 is from 17:00 EDT on July 12, 2021 to 16:59 EDT on July 18, 2021.

一个自然日：即美国东部夏令时前一天的 17:00 至当天的 16:59，如美国东部夏令时 2021 年 7 月 18 日的自然日是美国东部夏令时 2021 年 7 月 17 日 17:00 至 7 月 18 日 16:59。

- k. **The client must send an e-mail to payment.cn@scopemarkets.com, with their account number with the bonus code “DepositBonus202107”, in the e-mail subject to have the bonus credited to the account. Before adding the bonus in the client’s account, the client will need to confirm and agree with the Deposit Bonus Promotion Terms and Conditions. By sending a request and also confirming the receipt of the Deposit Bonus Promotion Terms and Conditions, the client will be legally bound by the terms and conditions of this bonus.**

客户需发送报名邮件至 payment.cn@scopemarkets.com 申请将赠金注入其该账户；并在电子邮件中注明其账号和赠金代码“DepositBonus202107”。在赠金注入账户之前，客户需要确认并同意赠金转现推广活动的所有条款和条件。通过发送赠金申请并确认收到赠金转现推广活动的条款和条件，客户将受到此赠金条款和条件的法律约束。

- l. In order to participate the client has to complete the Eligible Deposit(s) for the first time before sending the enrolment application.

客户参与本次活动，必须在发送参与申请邮件之前完成首笔合格入金要求。

- m. Each client can receive the **Welcome Credit Bonus** only once during the Promotion Period but can receive recurring **Deposit Credit Bonus** if further Eligible Deposit requirements are made, within 90 days from the day the First Eligible Deposit is performed, and the present Terms and Conditions are accepted (whichever comes later).

每个客户在活动期间只能获得一次迎新赠金；但只要符合合格入金需求，可以重复获得入金赠金，期限为完成第一笔合格入金并接受现行条款及细则（以后者时间线为准）起 90 天内。

- n. This Bonus promotion is applicable to clients from China and Malaysia only.

本次赠金活动仅适用于来自中国和马来西亚的客户。

4. Specific Deposit Bonus Promotion Terms

赠金转现推广活动具体条款

a. Eligibility to Participate:

活动参与者资格:

- 1) **Welcome Credit Bonus:** New Clients depositing for first time into their account by performing a First Eligible Deposit during the Promotion Period, will be entitled to receive a Welcome Credit Bonus as per the figures provided in the Bonus Schedule, one working day after they performed the First Eligible Deposit and accepted the present Terms and Conditions (whichever comes later). They are entitled to convert the Trade Cash Bonus, according to the figures provided in the Bonus Schedule. Maximum amount to be rewarded as Welcome Trade Cash Bonus is USD100. It shall be noted that if that at any time, New Client's net accumulated deposits fall below USD100 the account will be disqualified from the Promotion and the bonus credit will be removed.

“迎新赠金”：新客户在活动期间内首次向其真实交易账户中存入第一笔合格入金，将在完成第一笔合格入金并接受现行条款及细则（以后者时间线为准）后的一个工作日，根据赠金详情表中的赠金等级金额获得一笔“迎新赠金”。根据赠金详情表中所示的赠金等级金额，新客户有权在达到相应条件后将赠金转换为现金。可转换为现金的迎新赠金的最高金额为 100 美元。需要注意的是，如果在任何时候，客户的累计净流入金低于 100 美元，该账户将被取消活动资格，赠金金额也将被扣除。

- 2) **Deposit Credit Bonus:** Clients performing an Eligible Deposit into their account during the Promotion Period, will be entitled to receive the first Deposit Credit Bonus one working day after the time the Client has successfully requested such Bonus as per paragraph 3.k above and has accepted the Terms and Conditions (whichever comes later). Clients will also be eligible to convert the Trade Cash Bonus, according to the figures provided in the Bonus Schedule.

“入金赠金”：所有在活动期内有过合格入金的现有 Scope Markets 斯科普客户将有资格获得“入金赠金”。首笔赠金将在客户根据上文第 3.k.条成功申请赠金活动并接受条款及细则（以后者时间线为准）后一个工作日内存入客户的交易账户。客户可以在达成相应条件之后根据赠金详情表中的赠金等级，将赠金转换为现金。

c. When the Client is Eligible to receive any Bonus as provided hereunder, each round of the Bonus will be credited into client's account within one working day after each Eligible Deposit is made. When client meets the corresponding volumes as provided hereunder, which shall be generated within 6 months (180 days) from the day the Eligible Deposit was made for the first time, and the present Terms and Conditions are accepted (whichever comes later), Client will be eligible to receive Trade Cash Bonus according to the Bonus Schedule within 6 months (180 days) starting from the time that

the Eligible Deposit was made for the first time). In such case any un-converted Credit/Bonus will be removed.

当客户有资格获得本合同条款规定的任何赠金时，每笔赠金将在每笔合格入金后一个工作日内存入客户的交易账户。当客户达到活动要求相应的交易量（应在合格入金之日起 6 个月即 180 天内产生）并接受当前的条款及细则（时间线以后者为准）时，客户将在 6 个月后（自合格入金之日起之 180 天）根据相应赠金等级兑现赠金金额。同时，任何未兑现赠金都将被扣除。

- d. Volume will only be calculated if generated from the eligible account. Volume generated from same-name Account (slave account) will not be considered.

活动的交易量要求仅计算报名账号的交易量；同名账号（子账号）的交易量不能参与累计计算。

- e. To be eligible to convert the Trade Cash Bonus the Client needs to generate the Trading Volume Required under Option 12 or Option 18, as specified in the relevant tier according to client's net deposit as shown on the Bonus Schedule at a **round turn trade**. A round turn trade means opening and closing of a position. Provided that all the requirements are met, and the Client has successfully requested to convert the Trade Cash Bonus, the corresponding amount will be added in the Client's trading account Balance.

为能够达到赠金转现的资格，客户需要完成在赠金详情表中非凡礼遇一或非凡礼遇二所对应的相应赠金等级的净入金和交易量要求。一笔完整的交易包括头寸的开仓和平仓。客户如果已经满足所要求，并且成功申请赠金转现，那么相应的现金金额将会存入客户交易账户的余额中。

- f. Only volume lots generated on FX, Metal and Commodity symbols will be considered while calculating the Trading Volume Requirement. Volume generated on Shares, Indices and other CFDs will be excluded.

赠金交易量仅计算外汇、贵金属、大宗商品产品。股票、指数和其他 CFD 产品不参与赠金转现推广活动交易量计算。

- g. Illegal trading positions and positions performed through scalping will not be considered when calculating the Trading Volume Requirement. Scalping is defined as positions opened and closed or other side of the initial position is taken in less than 120 seconds.

订单持仓时间少于 120 秒以及任何违规交易产生的订单交易量均将不被计入赠金活动交易量。

- h. Where a client executes his/her trades through a Virtual Private Servers (VPS), Scope Markets reserves the rights to disqualify those trades and the volume generated will not be counted towards the required volume as specified in the Bonus Schedule.

如果客户通过虚拟专用服务器(VPS)进行交易。Scope Markets 将保留取消这些交易资格的权利，所产生的交易量将不计入赠金表中所规定的交易量。

- i. Clients can use any payment method provided by Scope Markets to deposit to participate to this Bonus promotion. Any internal transfer between Scope Markets accounts is not calculated as deposit.

客户可使用 Scope Markets 斯科普所提供的任何方式入金参加本次活动。在 Scope Markets 账户之间的任何内部转账不会计算为合格入金。

- j. Clients can choose to convert their Trade Cash Bonus under Option 12 or Option 18 as specified in the relevant tier according to client's net deposit as shown on the Bonus Schedule, at any time within the 180 days' timeframe, provided the volume requirements in accordance with the net deposit tiers are fulfilled. However, clients can convert their credit bonus into trade cash bonus one time only. Once a Client applies to convert his/her Credit Bonus into Trade Cash Bonus, the promotion will be deemed complete and all the remaining Deposit Credit Bonus and/or Welcome Credit Bonus in the Client's account will be removed.

客户只要在 180 天内的任何时间段完成对应非凡礼遇一或非凡礼遇二中赠金档位的交易量要求，就能申请将信用赠金转换为交易现金，且只能有一次转换机会。一旦客户申请将信用赠金转换为交易现金时，本次活动则视为已完成，并且所有未兑现剩余部分信用额赠金将被扣除。

Example 1: A new client deposited USD100 and received a Welcome Credit Bonus of USD20. If client deposits USD600 further within 30 days, client will receive USD52 top-up bonus (calculation based on $USD600 * 12\% - USD20$) Deposit Credit Bonus within one day. When client trades 18 lots within 6 months (180 days), client can choose to convert to Trade Cash Bonus under Option 12 and can send email to payment.cn@scopemarkets.com to apply for his Trade Cash Bonus USD72 (tier USD600-999). All the Deposit Credit Bonus and Welcome Credit Bonus in client's account will be removed.

例 1：新客户存入 100 美元可以获得迎新赠金 20 美元。如果客户在 30 日内再入金 600 美元，客户可以继续获取 52 美元补贴入金赠金（600 美元*12%-20 美元）。当

客户在 6 个月(180 天)内满足 18 手交易量要求时，客户可以选择信用赠金转现表中的非凡礼遇一，并可以发送电子邮件至 payment.cn@scopemarkets.com 申请将赠金信用额 72 美元（600 美元-999 美元档位）转换为现金。同时，所有未兑现剩余部分信用额赠金将被扣除。

Example 2: An existing client deposited USD5,000 and received a Deposit Credit Bonus of USD600. Client traded 136 lots within 2 months but decided not to exercise his right to convert under Option 12. Client continued to trade and completed 238 lots within 6 months (180 days), client then chooses to convert his Credit Bonus into Trade Cash Bonus under Option 18 and can send email to payment.cn@scopemarkets.com to apply for his Trade Cash Bonus USD900 (under tier USD5,000-7,999). All the Deposit Credit Bonus and Welcome Credit Bonus in client's account will be removed.

例 2：现有客户存入 5,000 美元，并获得 600 美元的入金赠金。客户在 2 个月内交易 136 手，但决定不行使他根据非凡礼遇一将信用赠金转换为交易现金的权利。客户继续交易，并在 6 个月（180 天）内完成了 238 手，然后客户选择将他的信用赠金转换为非凡礼遇二下所对应等级的交易现金，并发送电子邮件至 payment.cn@scopemarkets.com 申请将赠金信用额 900 美元（5,000 美元-7,999 美元档位）转换为现金。同时，所有未兑现剩余部分信用额赠金将被扣除。

- k. If a Client makes any withdrawal or internal transfer during the Promotion Period, the credit bonus he received will be deducted on a pro-rata basis.

如果客户在活动期内出金与内转资金（转出）至同名账户，将会按比例扣除信用额赠金。

Example 3: An existing client deposited USD20,000 and received Deposit Credit Bonus of USD2,400 (USD20,000*12%). Client then withdrew USD10,000 before the requirement of 450 lots is met, then USD1,200 Credit Bonus will be removed. He/she will then be under the bonus tier of USD8,000-14,999. If he/she achieves volume of 240 lots within six months from the day the Eligible Deposit was performed, he/she can send email to payment.cn@scopemarkets.com to apply for Trade Cash Bonus of USD960 under Option 12. The remaining Deposit Credit Bonus in his/her account will be removed.

例 2：现有客户存入 20,000 美元可以获得入金赠金信用额 2,400 美元（20,000 美元*12%）。如果客户在满足 450 手交易量之前出金 10,000 美元，那么 1,200 美元

入金赠金信用额将会被扣除, 他/她将处于 8,000-14,999 美元的档位内。如果客户在合格入金之日起 6 个月内满足 240 手交易量要求时, 可以发送电子邮件至 payment.cn@scopemarkets.com 申请 960 美元的交易现金金额。同时, 客户账户中剩余被兑现部分将被扣除。

Example 4: Client deposited USD6,000 to activate a new account and received USD720 as Deposit Credit Bonus. Client then continued to deposit USD5,000 and USD4,000 without performing any withdrawal, and the Deposit Credit Bonus would be increased by USD600 and USD480. Client is in the bonus tier of USD15,000-USD29,999 but he/she only fulfilled 240 lots. He/she is only eligible for Trade Cash Bonus for the lower tier USD8,000-USD14,999. Client can send email to payment.cn@scopemarkets.com to apply for Trade Cash Bonus of USD960. The remaining Deposit Credit Bonus in his/her account will be removed.

例 4: 客户存入 6,000 美元激活一个新账户, 可以获得入金信用赠金 720 美元。若客户再次增资入金 5,000 美元和 4,000 美元并且没有出金, 那么客户的入金赠金将分别提高 600 美元和 480 美元 (15,000-29,999 美元档位)。但客户只完成了 240 手的交易量要求时, 只能获得 8,000-14,999 美元档位的入金赠金。此时客户可以发送电子邮件至 payment.cn@scopemarkets.com 申请兑现赠金信用额 960 美元。同时, 客户账户中未被兑现部分将被扣除。

- I. The Welcome Credit Bonus amount is limited to a maximum of 100 USD; the Deposit Credit Bonus amount is limited to a maximum of 24,000 USD and the Trade Cash Bonus is limited to a maximum of 36,000 USD for any client.

- m. Where a client has multiple trading accounts with Scope Markets, he/she can only select one account to apply for the Deposit Bonus Promotion.

Finally, client only fulfilled 56 lots. Client is only eligible to apply for a Trade Cash Bonus of USD240 (Tier USD2,000-4,999). The remaining Deposit Credit Bonus in his/her account will be removed.

例 5: 现有客户入金 6,000 美元, 客户可获得 720 美元的入金赠金信用额; 客户此时所对应的赠金等级为 5,000-7,999 美元档位, 需满足 136 手的交易量才有资格将赠金信用额兑现。但在最后, 客户只完成了 56 手的交易量, 那么客户只能申请相对应的 2,000-4,999 美元档位的 240 美元赠金金额兑现。同时, 客户账户中所剩余未兑现部分将被扣除。

Example 6: Client deposited USD6,000 on July 13, 2021 and received credit bonus of USD720. Client traded 56 lots and sent email request to settle the credit on July 30, 2021. Therefore, client was eligible to convert into USD240 Trade Cash Bonus. Total credit bonus of USD720 in his/her account will be removed.

例 5: 客户在 2021 年 7 月 13 日入金 6,000 美元, 并获得了赠金信用额 720 美元, 客户于 2021 年 7 月 30 日发送邮件申请提前结算兑现, 此时交易量仅为 56 手, 因此, 客户可获得 240 美元的赠金对兑现, 之前账户中 720 美元赠金信用额将被扣除。

- r. Notwithstanding the above, if at any time, the client's net accumulated deposits fall below USD100, the account will be disqualified from the promotion and the Bonus will be removed at once.

Example 7: Client deposited USD10,000 on July 2 and received USD1,200 Deposit Credit Bonus. Client account stopped out on July 8, because the balance in the trading account was -USD900. Client further deposited USD2,000 on July, the Client will be eligible to receive USD240 Deposit Credit Bonus from his new deposit. Client is awarded a total of USD1,440 bonus but the USD900 will be utilized to adjust the negative balance in his account. The Client will then have equity of USD2,540 (USD2,000+1,200+240-900). Finally, Client traded 420 lots and he will be entitled to Trade Cash Bonus of USD1,440 (tier USD8,000-14,999), but the actual Trade Cash Bonus he should receive is USD540 (USD1,440 – 900) since USD900 has already been utilized to adjust the negative balance in his account.

例 6: 客户 7 月 2 日入金 10,000 美元，获得入金赠金信用 1,200 美元。在 7 月 8 日，客户账户爆仓，且账户余额为-900 美元。如果客户在 7 月 15 日再次入金 2,000 美元，客户获得追加的入金赠金信用 240 美元。因此，客户将累计收到 1,440 美元的入金信用赠金，调整客户账户负余额 900 美元后，账户可用净值为 2,540 美元（2,000 美元 +1,200 美元+240 美元-900 美元）。最后客户交易了 420 手，那么他将可以兑现的赠金金额是 1,440 美元（8,000-14,999 美元档位）。需要注意的是，客户实际可以赠金转现的金额是 540 美元（1,440 美元-900 美元），其中 900 美元已经被用于调整其账户中之前的负余额了。

- t. Shall a client's account balance fall below zero with equity less than zero with no opened position, the system will automatically perform a negative balance adjustment and client's credit will be cancelled.
